## WHEN RIDING IN THE FOREST YOU MUST:

- **Wear an approved riding helmet and a Kake Hōiho hi-vis vest.**
- Carry your receipt on you at all times. You must produce your receipt if asked by Kaitiaki or security. You could be asked to leave the forest if you cannot show your receipt.
- Have a tag on your saddle (or bridle) with a contact name and number in case you lose your horse. If you lose a horse in the forest phone the office 09 420 9566 (9-5 Mon-Fri), First Security 0800 347 787, or forest security 027 535 5770.
- Ride only in areas or on trails that are open to horse riding. Use the marked trails **only**.

Keys will not be issued to riders 16 or under. Riders 16 or under must be supervised by a registered adult rider.

## ACCESS:

At times the park could be closed due to Covid-19 or forest and weather events that may compromise the safety of riders and their horses. We endeavour to notify riders about all changes to access. You can stay up to date with announcements at [www.woodhillforest.co.nz](http://www.woodhillforest.co.nz)

- **Lock all gates behind you immediately.** Unlocked gates provide unauthorised access.
- Access may be restricted during high fire risk, high winds, or due to harvesting activities.
- Keep grazing gates closed to stop stock wandering.
- Vehicle access is only permitted to the official car parking area. All vehicles entering the car park must be road legal and display a casual entry form.

## FOR YOUR SAFETY, AND THE SAFETY OF OTHERS:

Horse riding is a high-risk activity, when you ride in Te Ngahere o Woodhill you do so at your own risk and must be aware of the hazardous environment: **THERE ARE WILD ANIMALS IN THE FOREST THAT MAY SPOOK YOUR HORSE.** Please obey all notices (including closures or taped off areas) in the forest. Woodhill is a commercial production forest. There is year-round harvesting and other forestry activity.

- Logging trucks and other light and heavy vehicles have right of way on forest roads. Take extra care when crossing roads within the forest. You can cross forest roads, but you cannot ride along them.
- Report all hazards or damage immediately to Kaitiaki, phone the office 09 420 9566 ext.1 (9-5 Mon-Fri) or email [kake@kaiparangahere.com](mailto:kake@kaiparangahere.com)
- Dogs are welcome in the forest with you; they must be under full control at all times and tied up (on a lead) when in the car park.
- **No accompanying pedestrians or cyclists, riders only.**
- **No riding during the hours of darkness**

## HELP US PROTECT THE FOREST AND THE ENVIRONMENT:

- This is a smoke free forest. No Smoking anywhere on forest land. Report any fires to 111
- Report any suspicious activity.

## PENALTIES:

- Lost keys will incur a fee of \$100.00
- Riders locked in after forest closing time will incur a let-out fee – First Security 0800 347 787
- Riders not following the terms and conditions could have their memberships suspended or cancelled and/or be asked to leave the horse park.

***Horse gate locks are changed, and annual registrations are due every 1st October. A new key is purchased with each annual registration and old keys must be returned.
